



## ISLANDS INTERNATIONAL CHALLENGE CUP 22<sup>ND</sup> MATCH

### NOTICE OF RACE

#### 1. RULES AND ADVERTISING

- 1.1 The races will be governed by rules as defined in The Racing Rules of Sailing (RRS) including Appendix D Team Racing Rules. No national authority prescriptions will apply.
- 1.2 Personal floatation devices (PFD's) with a rating of 11 pounds or 50 newtons of floatation shall be worn at all times while on the water by competitors, other than for brief periods while adding or removing clothing. All competitors must supply their own PFD's.

#### 2. ELIGIBILITY AND ENTRY

- 2.1 Teams from invited clubs may enter by completing the entry form and sending it together with the required entry fee to the club. Sonar type boats will be provided to each team by the Organizing Authority.
- 2.2 Each competing team shall consist of skippers and crews for two boats with three or four crew per boat. The total crew weight for each boat shall not exceed 720 pounds (326.6kg.).
- 2.3 The Islands International Challenge Cup is a Corinthian regatta. Therefore, all competitors are to be members, spouses or dependents of members in good standing with their club and not classified as Group 3 by ISAF. No helmsman who has helmed a yacht in any of the following events: the ISAF Team Racing World Championship, the Wilson Trophy, U.S. Team Race Championships or the British-American Cup is eligible for this event. The goal is to have team members from the regular sailing membership of the clubs invited.

#### 3. ENTRY DEADLINES, FEES AND DAMAGE DEPOSIT

The electronic Entry Form and a registration fee per team of \$2,000 USD are required by May 1, 2019 to confirm a club's participation in the regatta. A refundable damage deposit of \$1,000 USD per-team (\$500 USD per-boat) will be paid at registration.

## **5. VENUE AND SAILING INSTRUCTIONS**

## **6. COURSES**

At the discretion of the Race Committee, courses may be a Starboard or Port Box, a Starboard or Port Triangle, or Windward/Leeward "2K" course.

## **7. SAILS**

The Islands International Challenge Cup is a non-spinnaker event. Sails provided will be a main and a jib.

## **8. SCORING**

Shall be in accordance with RRS, Appendix D, except as modified by the Sailing Instructions.

## **9. PRIZES**

The Islands International Challenge Cup shall be awarded to the winning team. The "Islands International Challenge Cup" shall remain at Seawanhaka and "keeper" trophies will be presented.

## **10. WAIVER & RELEASE**

Competitors will be required to sign a waiver and release of liability favoring the Organizing Authority, Event Sponsors, and the Officials of the Regatta.
