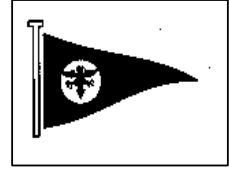

Annual Subscriptions:

Annual subscriptions shall be due and payable to Newtownards Sailing Club (NSC) by 1st March of any year. Failure to renew by 31st March of any year will cause key card disablement. Furthermore memberships not renewed by this date will be subject to a rejoining fee equal to the entrance fee specified for new membership in any year.

This rejoining penalty will be strictly enforced.

The membership of any member whose subscription remains unpaid on 30th April shall be deemed to be automatically cancelled and a full re-application shall be necessary, unless this is waived by the Executive Committee because of special reasons or circumstances. If re-application is waived, any member who has not paid their annual subscription by 30th April will be required to pay a sum of £5 towards key card re-enablement

in addition to the annual subscription and rejoining penalty.

Any member who fails to pay their annual subscription by 30th April shall, up to the date of actual payment, forfeit the right to any points, scores, or suchlike gains of any type achieved by them, in relation to participation in any event, race, or like activity in any way related to membership of the club during that membership year.
